



## Commitment to comply with EU embargo rules concerning Russia and Belarus

Dear Sir or Madam,

As a supplier of goods that are subject to the embargo against the Russian Federation and Belarus, we are obliged by law (in this case the Embargo Regulation and its Commission Implementing Regulations) to enter into contractual agreements with you. We are fulfilling this responsibility with this letter.

As part of our product range is covered by Articles 2 (2a), 3 (3k) and 12 (12g) of Council Regulation (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (and its Commission Implementing Regulations) and by Articles 1 (1s) and 8 (8g and 8ga) of Council Regulation (EC) No 765/2006 of 18 May 2006 concerning restrictive measures in view of the situation in Belarus and the involvement of Belarus in the Russian aggression against Ukraine (and its Commission Implementing Regulations), we are obligated to draw your attention to the following.

The export and transit of some of our goods to the Russian Federation and Belarus is prohibited. These regulations must be observed.

On the basis of Article 12g of Council Regulation (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (and its Commission Implementing Regulations) and Article 8g of Council Regulation (EC) No 765/2006 of 18 May 2006 concerning restrictive measures in view of the situation in Belarus und the involvement of Belarus in the Russian aggression against Ukraine (and its Commission Implementing Regulations), we are obliged to prohibit you from re-exporting to Russia or Belarus and re-exporting for use in Russia or Belarus the goods covered by this regulation.

As a buyer, you are obligated to comply with the above-mentioned regulations and, if necessary, to ensure with your customers that the regulations are complied with. As the buyer, you shall establish and maintain an appropriate monitoring mechanism to detect any violations by third parties in the wider supply chain, including resellers. The buyer shall inform Uniflex Hydraulik GmbH immediately of any infringement, including any relevant activities of third parties.

Should Uniflex Hydraulik GmbH become aware of a violation of the above regulations, Uniflex Hydraulik GmbH will terminate the business relationship at the time it becomes known. Deliveries will no longer be made. We ask for your understanding for this restrictive interpretation, which is required by Council Regulation (EU) No 833/2014 of 31 July 2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (and its Commission Implementing Regulations) and Council Regulation (EC) No 765/2006 of 18 May 2006 concerning restrictive measures in view of the situation in Belarus und the involvement of Belarus in the Russian aggression against Ukraine (and its Commission Implementing Regulations).
